

CONFIDENTIALITY AGREEMENT

This Confidentiality Agreement ("Agreement") will confirm our mutual understanding in connection with **ADVANTEDGE ADVISORS**, providing, and your receipt of, information regarding the designated Company noted above ("The Company")

1. Information means all oral or written data, reports, records or materials ("Information") obtained from us or The Company, including the name, address and type of business of The Company, the knowledge that The Company may be considering a sale, or even the fact that Information has been provided. Information is being furnished solely in connection with your consideration of the acquisition of The Company and shall be treated as "secret" and "confidential" and no portion of it shall be disclosed to others, except to those of your employees and agents whose knowledge of the Information is required for you to evaluate The Company as a potential acquisition and who shall assume the same obligations as you under this Agreement.
3. The undersigned further agrees that it will not interfere in any way with any business of The Company through the use of any Information or knowledge acquired under this Agreement nor use any such Information for its own account.
4. It is understood that The Company is the intended party and beneficiary whose rights are being protected and may enforce the terms of this Agreement as if it were a party to this Agreement.
5. All Information shall be promptly returned or destroyed, as directed by us or The Company.
6. It is understood that (a) no representations or warranties are being made as to the completeness or accuracy of any Information and (b) any and all representations and warranties shall be made solely by The Company in a signed acquisition agreement or purchase contract and then be subject to the provisions thereof.
7. The undersigned hereby has been made aware that AdvantEdge Advisors is engaged as a non-agent marketing advisor and transaction facilitator. With regard to any real properties involved in the proposed sale, AdvantEdge is engaged in a statutory broker capacity.
8. The undersigned acknowledges the responsibility to perform due diligence review at its own cost and expense prior to any acquisition.
9. The undersigned agrees to make any and all letters of intent or offers directly through AdvantEdge Advisors.
10. The respective obligations of the parties under this Agreement shall survive for a period of two years following the date hereof.
